Lighthouse-keepers: Business and Human Rights Cooperation Network

30 December 2021 – 31 July 2023



The objective of the project was **to create and develop a network of BHR experts** and **to raise awareness of business and human rights in the region of Central and Eastern Europe and Central Asia.**

The project was led by the Polish Institute for Human Rights and Business (PIHRB), joined by:

- the Yaroslav Mudryi National Law University (Ukraine),
- the ALDA Association for Sustainable Democracy (Iceland),
- the Icelandic Ombudsman for Children.

This Working Paper Volume comprises 15 Business & Human Rights (BHR) case studies from Central & Eastern Europe and Central Asia developed by the participants of the first edition of the Central and Eastern Europe and Central Asia Summer Academy on Business and Human Rights (2022).

This publication is intended to be used as self-learning or/and teaching material so that when teaching BHR in a region, references can be made to region-specific situations that are more tangible, relevant, and easier to relate by learners than cases from other parts of the world. Each case study starts with a short context description, followed by questions addressing core Human Rights Due Diligence (HRDD) elements that any company finding itself in such a situation should ask itself and be able to answer.

This report - based on discussions during the two workshops regarding the Icelandic experience in shaping relations between NGOs and businesses, as well as inputs from participants from Poland and Ukraine, is an attempt to draw some preliminary conclusions as to the state of these issues in Iceland, as well as considering some more general lessons which may be drawn from the discussions.

Ethical Principles of Business and NGO Cooperation

Holding Corporations Accountable...

The webinar is focused on the judicial and non-judicial mechanisms and practices of their operations to establish the liability of corporations in aiding and abetting human rights violations. A special emphasis is placed on barriers to access to justice in different countries of the region in cases of business related human rights violations. Also discussed is when a parent company can be held liable under the law of civil remedies for the wrongful acts and/or omissions of a subsidiary or independent contractor in a supply chain.

Children's Rights and Business

Children are one of the vulnerable groups in the societies of Eastern Europe and Central Asia. All children, no matter where they live and no matter their circumstances have the right to be protected, nurtured, and to be free from violence, abuse, neglect, maltreatment, and exploitation, as the Convention on the Rights of the Child sets out. Businesses affect children's rights in several dimensions. As for the normative framework for children's rights, companies need to consider the Convention on the Rights of the Child as part of the international framework in which they operate.

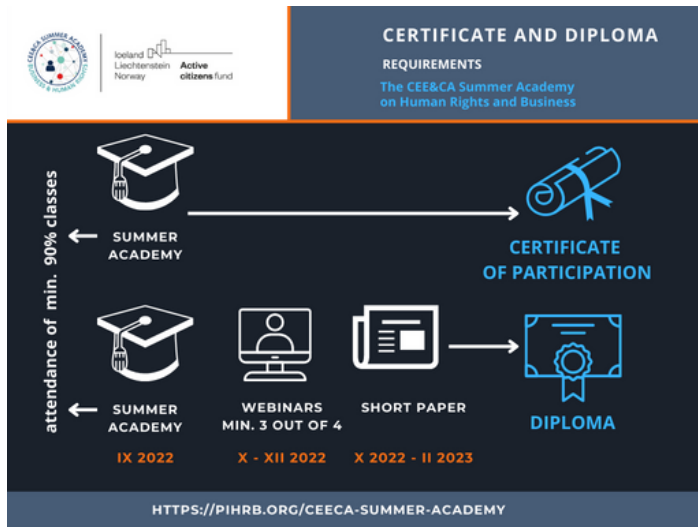
The conference provided opportunity to explore the situation in the region but also discuss legislation and trends that do or will have impact on it.

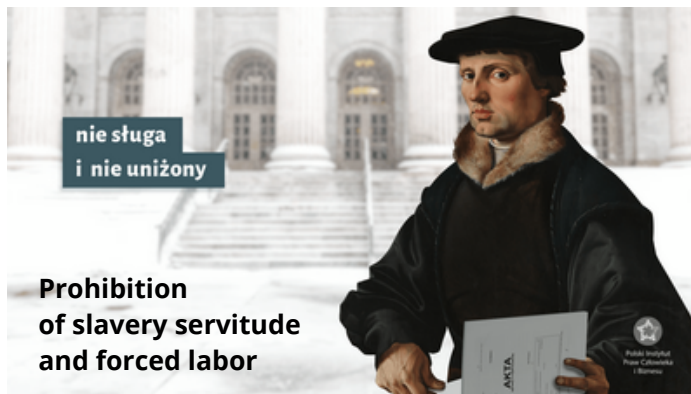

Currently 34 Information sheets are available in Polish, as well as partially in English and Russian. We plan to develop the remaining information sheets in the months to come.

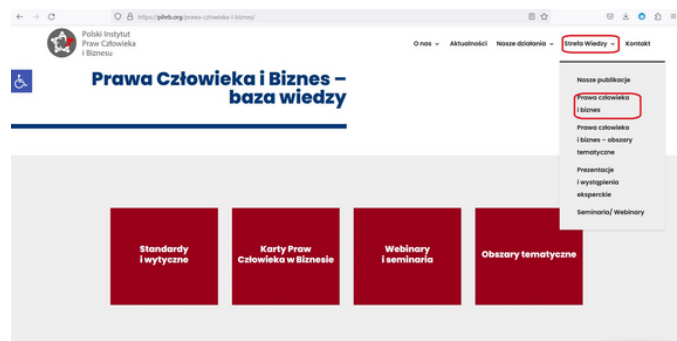

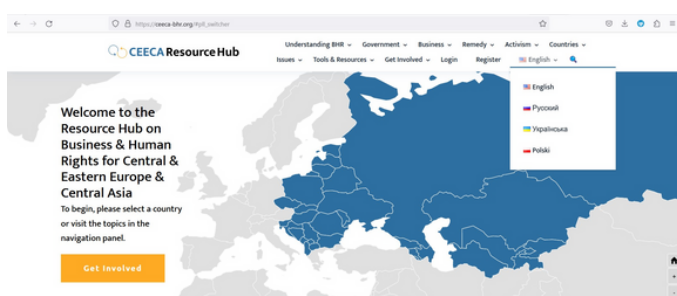
